Applicants have up to 120 days from the insulation installation to submit a rebate application. If the 120 days have passed, the applicant may still be eligible for a rebate if the Program Year budget has not been exhausted.

TERMS AND CONDITIONS

- Installers may be eligible for a \$50 rebate per unit installed, subject to change in accordance with Colorado labor standards. For questions regarding installer rebate please call the number below.
- CNG must provide the main heat source fuel. Heat Pumps are considered main heat source regardless of settings, therefore, no heating or envelope measure rebates would be eligible when a Heat Pump is present.
- All submissions must include dated sales invoices/receipts. Invoices/receipts must include equipment retail price.
- No rebate will exceed equipment/installation purchase price.
- Rebates will be paid on a first-come, first-served basis and are subject to budget availability and program changes. The program will end when the budget is depleted. Funds are limited.
- Applicants have up to 120 days from the installation of the insulation to submit a rebate application. If the 120 days have passed, the applicant may still be eligible for a rebate if the Program Year budget has not been exhausted.
- Colorado Natural Gas reserves the right to inspect all rebated equipment.
- This program is subject to regulatory rules and orders. Colorado Natural Gas reserves the right to change or end any portion of this program without notice.
- To avoid delay, the dealer invoice returned with your rebate application must include the date of installation, and installation address. Insulation cost, labor, and tax must be itemized. Labor charges for self-installed jobs are not eligible for rebates.
- Checks will be made payable to customer shown on invoice. Builders and installers are eligible to receive their customer's rebates if a discount to the customer for the rebate amount is shown on the submitted invoice.
- Please allow 6-8 weeks from the date a completed application is submitted to receive a rebate payment.
