Your cost per therm is changing from your current GCA rate and goes into effect for the period from November 2024 through March 2025.

If you wish to participate as a party in this matter, you must file written intervention documents in accordance with the PUC's Rules.

Anyone who desires to file written objection or written intervention documents to the proposed action shall file them with the Colorado Public Utilities Commission, 1560 Broadway, Suite 250, Denver, Colorado, 80202 at least one day before the proposed effective date. Members of the public may attend any hearing and may make a statement under oath about the proposed change whether or not a written objection or request to intervene has been filed.
